## MEMORANDUM OF UNDERSTANDING

- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.



D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES  
SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives; and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Audyogik Tantra Shikshan Sanstha's, Institute of Industrial and Computer Management and Research, MBA@IICMR, Nigdi, Pune** and its related wings. The Parties shall keep each other informed of potential opportunities and shall



share all information that may be relevant to secure additional opportunities for one another.

- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

## **15 CLAUSE 2 SCOPE OF THE MoU**

- 2.1 The budding Managers and Faculty from the institution could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student and faculty community to enhance their skills and knowledge.
- 2.2 **Visits:** Organization and Institution interaction will give an insight into the latest developments / requirements of the sector; the Second Party to permit the Faculty and Students of the First Party to visit its service centers and also involve in Training Programs for the First Party. The exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its service Sites for the hands-on training of the learners enrolled with the First Party.
- 2.3 **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs, as per internship Policy. The Second Party will also engage in disseminating the Internship opportunities available with them.



- 2.4 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.5 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.6 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.7 **Case Study Development:** MBA@IICMR aims to develop native content, rooted in Indian realities, for classroom teaching. Developing cases based on current issues, challenges and initiatives of industry is one such activity. With an objective of strengthening industry institute connect and at the same time expose the faculty members of MBA@IICMR to real life business problems. These cases will be used for classroom teaching and will help students understand application of management concepts in Indian context. The second party shall, subject to their internal policy guidelines, help the first party to develop such case studies. The first party shall not publish any content developed in association with the second party, without the express written permission of the second party.
- 2.8 **Faculty Sabbatical:** MBA@IICMR is also keen to depute faculty members for working on a live project with the industry. Such projects can range from one week duration to six months duration and will be driven by mutually identified key deliverables.
- 2.9 **Live Projects:** MBA@IICMR also seeks live projects for the students to expose them to the knowhow of the industry.
- 2.10 **Shadowing Activity:** MBA@IICMR would like to extend and strengthen this association, in terms of number of students and areas of Marketing, Finance, HR, Operations, Supply Chain Management, Analytics, International Business, Agri Business, Healthcare, Hospitality, BFSI, Retailing, Real Estate, etc.



- 2.11 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein
- 2.12 There is no financial commitment on the part of the **Audyogik Tantra Shikshan Sanstha's, Institute of Industrial and Computer Management and Research, MBA@IICMR, Nigdi,Pune** , the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

#### 16 **CLAUSE 3 INTELLECTUAL PROPERTY**

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

#### 17 **CLAUSE 4 VALIDITY**

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period of **ONE Year**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Training Partner** or

the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

#### 18 **CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES**

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use





the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.


